

ALL OF LOT 154 AND LOT 155, NORTH OGDEN COVE 2ND AMENDMENT, A PART OF NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 7 NORTH, RANGE 1 WEST, S.L.B. & M. U.S. SURVEY, NORTH OGDEN CITY, WEBER COUNTY, UTAH.

NEW DESCRIPTION FOR AMENDED SUBDIVISION
