NARRATIVE

- 1. The purpose of the survey is to identify the boundaries of the property shown which is described in Quit Claim Deed recorded as E#2910235 on March 16, 2018. This deed is Subject to a right of way over what is essentially the north 16 feet of the property and contains a statement which reads, "which right—of—way is also reserved by grantors for the benefit of the property adjacent thereto on the north of said right—of—way." The easement is shown and noted hereon.
- The basis of bearing is as stated in the boundary description shown hereon. . The block lines and original lots dimensions were prorated due to the slight excess in the block as identified by the city monumentation. This also meant that the deed dimensions are prorated to compensate for the excess since the deeds appear to be written based on the historic record of the block which is found in Plat book 2 page 1 of the county records.
- 4. An existing fences on the south boundary and a portion of the westerly boundary is on the property line, however, the fence line on the north of the property is not on the line nor is it straight.
- 5. The prorated deed dimensions have been held as the location for the property boundaries. The corners have been monumented as noted.
