







Vicinity Map

PART OF THE NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT POINT IN THE EXISTING NORTHERLY RIGHT-OF-WAY LINE OF LARSON LANE, SAID POINT IS 1,934.99 FEET S00°00'08"W ALONG THE QUARTER SECTION LINE AND 88.58 FEET S89'59'52"E FROM THE NORTH QUARTER CORNER OF SAID SECTION 8, SAID NORTH QUARTER CORNER BEING 2,645.76 FEET N89°05'39"W FROM A BRASS CAP MONUMENT MARKING THE NORTHEAST CORNER OF SAID SECTION 8 (NOTE: BASIS OF BEARINGS FOR THIS DESCRIPTION IS N89'10'39"W 5,296.78 FEET BETWEEN FOUND BRASS CAP MONUMENTS MARKING THE NORTHEAST AND NORTHWEST CORNERS OF SAID SECTION 8), AND RUNNING THENCE N23'17'16"W 98.18 FEET; THENCE N33'59'02"E 85.02 FEET; THENCE N14'56'43"W 74.76 FEET, MORE OR LESS, TO A POINT IN THE SOUTHERLY LINE OF THOROUGHBRED MEADOWS 1ST AMENDMENT; THENCE N61'12'05"E 108.70 FEET ALONG SAID SOUTHERLY LINE; THENCE S00°51'03"W 239.06 FEET, MORE OR LESS, ALONG A FENCE. 


## NARRATIVE

THIS SURVEY WAS REQUESTED BY BRUCE BROWN IN ORDER TO IDENTIFY AND MONUMENT THE BOUNDARY OF THE SUBJECT PARCEL (TAX ID 11-027-0039) ON THE GROUND AND FACILITATE A BOUNDARY LINE AGREEMENT BETWEEN PARCELS 11-027-0039 AND 11-027-0067, WHOSE SHARED LINE HAS COME INTO QUESTION.

BOUNDARY DETERMINATIONS WERE AS FOLLOWS:

THE NORTHERLY LINE OF THE SUBJECT PARCEL IS DETERMINED BY THIS SURVEY TO BE THE THE SOUTHERLY LINE OF THOROUGHBRED MEADOWS 1ST AMENDMENT, A SUBDIVISION RECORDED AS ENTRY 2664063, BOOK 74, PAGE 88 IN THE OFFICE OF THE WEBER COUNTY RECORDER. THE EASTERLY BOUNDARY LINE IS DETERMINED BY THIS SURVEY TO BE AN OLD FENCE OF LONG RELIANCE AND IT'S PROJECTED BEARING TO THE EXISTING NORTHERLY RIGHT—OF—WAY LINE OF LARSON LANE. THE SOUTHERLY LINE IS BOUNDED BY THE EXISTING NORTHERLY RIGHT—OF—WAY LINE OF LARSON LANE AS DEFINED BY HARRISVILLE CITY ROADWAY PLANS FOR PROJECT F—LC57(26), OBTAINED FROM THE HARRISVILLE CITY ENGINEER'S OFFICE. THE WESTERLY LINE OF THE SUBJECT PARCEL HAS BEEN MONUMENTED BY REBAR AND CAP, AS SHOWN HEREON, AT THE DIRECTION OF BRUCE BROWN, WHO WAS PRESENT AT THE TIME OF SURVEY. THIS LINE IS INTENDED TO BE SUBJECT TO A BOUNDARY LINE AGREEMENT TO FOLLOW RECORDATION OF THIS PLAT.
