SURVEYOR'S NARRATIVE

THIS SURVEY WAS REQUESTED BY MR. DAVID JONES OF PARADIGM REAL ESTATE FOR THE PURPOSE OF RE-ESTABLISHING THE BOUNDARIES OF THE HEREON DESCRIBED PARCELS OF LAND.

BRASS CAP STREET MONUMENTS WERE FOUND AT THE INTERSECTIONS OF 26TH STREET AND ADAMS AVENUE, 26TH STREET AND JEFFERSON AVENUE, 27TH STREET AND ADAMS AVENUE, AND 27TH STREET AND JEFFERSON AVENUE. A LINE BEARING NORTH 0°58'00" EAST BETWEEN SAID BRASS CAP MONUMENTS IN JEFFERSON AVENUE AT 26TH STREET AND 27TH STREET, WAS USED AS THE BASIS OF BEARINGS FOR

A BOUNDARY & TOPOGRAPHIC SURVEY PREPARED BY MCNEIL ENGINEERING FOR LAPORTE CONSTRUCTION, DATED AUGUST II, 2003, AND FILED OCTOBER 14, 200; A PROPERTY SURVEY PREPARED BY HANSEN AND ASSOCIATED, INC, FOR R&J REAL ESTATE HOLDING, LLC, DATED MARCH 13, 2012, AND FILED AUGUST 7, 2012; WERE USED AS REFERENCE FOR THIS SURVEY. BOUNDARIES OF THE PARCELS WERE ESTABLISHED BY INFORMATION OF RECORD AND FOUND EVIDENCE OF OCCUPATION

PROPERTY CORNERS ARE SET AS INDICATED HEREON.

BEGINNING AT THE SOUTHWEST CORNER OF SAID LOT I BEING THE NORTH LINE OF 27TH STREET; RUNNING THENCE NORTH 0°57'28" EAST (NORTH REC.) 120.00 FEET ALONG THE WEST LINE OF SAID LOT I, THENCE SOUTH 89°02'42" EAST 83.08 FEET (EAST 82.5' REC.): THENCE SOUTH 0°57'31" WEST (SOUTH REC.) 120.00 FEET TO SAID NORTH LINE OF 27TH STREET; THENCE NORTH 89°02'42" WEST 83.07 FEET (WEST 82.50 FEET REC.) TO THE POINT OF BEGINNING.
