


BASIS OF BEARINGS

THE BASIS OF BEARING FOR THIS PLAT IS THE MONUMENT LINE BETWEEN A FOUND OGDEN CITY SURVEY MONUMENT IN THE INTERSECTION OF 28TH STREET AND HARRISON BOULEVARD AND A FOUND OGDEN CITY SURVEY MONUMENT IN THE INTERSECTION OF 29TH STREET AND HARRISON BOULEVARD, SHOWN HEREON AS: S00'32'00"W.

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH THE BOUNDARY OF THIS PARCEL ON THE GROUND FOR FUTURE DEVELOPMENT. ALL CORNERS NOT FOUND WERE SET WITH A 5/8" REBAR AND PLASTIC CAP STAMPED "REEVE AND ASSOCIATES".


