

A PART OF THE NORTHEAST QUARTER OF SECTION 28, TOWNSHIP 6 NORTH, RANGE 1 WEST, OF THE SALT LAKE BASE AND MERIDIAN AND A PART OF LOTS 25 TO 28 INCLUSIVE, BLOCK 3, VALLEY VIEWADDTION TO OGDEN CITY. BEGINNING AT A POINT ON THE NORTH RIGHT-OF-WAY LINE OF 19TH STREET BEING LOCATED NORTH 88°40'00" WEST 102.29 FEET AND NORTH 0°00'00" EAST 33.01 FEET FROM THE OGDEN CITY SURVEY MONUMENT AT THE INTERSECTION OF ECCLES AVENUE AND 19TH STREET; RUNNING THENCE ALONG SAID NORTH RIGHT-OF-WAY LINE NORTH 88°40'00" WEST 70.67 FEET; TO THE PLATTED ALLEY WAY THENCE ALONG SAID ALLEY WAY NORTH 1°22'11" EAST 100.00 FEET; THENCE SOUTH 88°37'49" EAST 70.69 FEET; THENCE SOUTH 1°22'36" WEST 99.96 FEET TO THE POINT OF BEGINNING. CONTAINING 7066 SQUARE FEET OR 0.16 ACRES MORE OR LESS.

NARRATIVE


THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY THOMAS BENNET. THE BASIS OF BEARING IS THE STREET CENTER LINE OF THE 19TH STREET BETWEEN ECCLES AVENUE AND JACKSON AVENUE, WHICH BEARS SOUTH 88°40'00" EAST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BY WARRANTY DEED RECORDED AS ENTRY NUMBER 3018012, AND DEEDS OF ADJOINING PROPERTY OWNERS. RECORD OF SURVEY NUMBER 004039 WAS ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON.
