

BASIS OF BEARINGS




LEGAL DESCRIPTION

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE PROPERTY BOUNDARY ON THE GROUND. THE BOUNDARY WAS DETERMINED BY FOUND EXISTING T POSTS AND REBAR MARKING PROPERTY CORNERS OF SURROUNDING LOTS, INCLUDING LOTS 47 AND 48, 48 AND 49, AND 49 AND 50. A BEST FIT ROTATION WAS USED TO PLACE THE PROPERTY CORNERS. THE SECTION TIES SHOWN HEREON ARE MEASURED BEARINGS AND DISTANCES FROM THE ABOVE DESCRIBED SOLUTION.
