I, JEREMIAH R. CUNNINGHAM, A PROFESSIONAL LAND SURVEYOR ACCORDING TO THE LAWS OF THE STATE OF UTAH, DO CERTIFY THAT I HAVE SURVEYED THE PARCEL OF GROUND SHOWN HEREON ACCORDING TO UTAH STATE CODE 17-23-17.



NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO CLARIFY ERRORS ON THE DEDICATION PLAT FOR AND IN DEVELOPMENT OF PANUNZIO FARMS PRUD SUBDIVISION (ENTRY #3089223, WEBER COUNTY RECORDER; SEE BELOW). THE BASIS OF BEARING WAS SET BETWEEN THE SECTION CORNER MONUMENTS, AS SHOWN. POINTS SHOWN HEREON WERE SET AS PART OF THE DEVELOPMENT PROCESS AND ACCURATELY REFLECT THE LOCATION AND DIMENSIONS OF THE LOTS. CORNERS FRONTING STREETS WERE MARKED AT AN OFFSET USING MAG NAILS SET IN THE CURB LINE ON AN EXTENSION OF THE LOT LINE (DISTANCES SHOWN HEREON).

AS STATED IN THE PLAT NARRATIVE FOR PANUNZIO FARMS, THE PLAT WAS PREPARED BASED ON A GARDNER ENGINEERING SURVEY ON THE SAME PROPERTY (SURVEY FILE #5467). THE PATENT ERROR IS THE LENGTH OF THE TIE FROM THE SECTION LINE, WHICH IS LABELED ON THE PLAT AS "118.43 FEET", BUT IS LABELED ON THE GARDNER SURVEY AS "1663.85 FEET". THE GARDNER SURVEY TIE IS THE CORRECT TIE.

NOTWITHSTANDING THE ERROR, THE DEDICATION PLAT CORRECTLY POSITIONS THE PROPERTY (BETWEEN 4400 SOUTH STREET AND 4450 SOUTH STREET), AND THE ADJOINING PARCELS ARE LABELED WITH THE APPROPRIATE TAX PARCEL NUMBERS. AFTER CONVERSING WITH THE CITY PLANNING DEPARTMENT, THEY REQUESTED THAT I FILE THIS SURVEY AND RECORD AN AFFIDAVIT TO CLARIFY AND CORRECT THIS ERROR.

AN ADDITIONAL ERROR WAS DISCOVERED DURING DEVELOPMENT OF THE SUBDIVISION WHERE THE DEVELOPMENT DRAWINGS PLACED ROAD IMPROVEMENTS AT THE END OF THE CUL-DE-SAC ABOUT 3.5 FEET TOO FAR TO THE SOUTH. THIS CREATED A SITUATION WHERE A PORTION OF THE SIDEWALK ENCROACHES INTO LOTS 7-10. THE MAXIMUM ENCROACHMENT OF THE SIDEWALK IS ABOUT 2.4 FEET AT THE APEX OF THE CUL-DE-SAC. THE ENCROACHMENT INTO LOT 7 AND LOT 10 IS ONLY ABOUT 1.0 FOOT. NONETHELESS, A 3-FOOT EASEMENT DESCRIPTION HAS BEEN PREPARED FOR PUBLIC ACCESS ALONG THE SIDEWALK.

A CHANGE WAS MADE TO THE LOCATION OF THE CENTERLINE MONUMENT AT THE INTERSECTION OF 4400 SOUTH STREET AND 850 WEST STREET SUCH THAT THE MONUMENT SHALL BE SET AT THE SOUTHERLY RIGHT-OF-WAY LINE INSTEAD OF THE CENTERLINE INTERSECTION. THIS CHANGE IS WARRANTED BECAUSE THE DEVELOPED PORTION OF THE ROADWAY IS ONLY ON THE SOUTH SIDE OF THE RIGHT OF WAY. THE CENTER LINE INTERSECTION FALLS IN THE MIDDLE OF WEST-BOUND TRAFFIC. THE ADJUSTED POSITION OF THE MONUMENT WILL PROTECT IT WHEN FUTURE DEVELOPMENT EXPANDS THE ROADWAY.

FINALLY, A 6.0-FOOT STRIP IN THE NORTHEAST CORNER OF THE WHOLE PARCEL WAS SOLD TO THE NEIGHBOR. A CORRECTED STRIP DESCRIPTION HAS BEEN PREPARED FOR A CORRECTIVE DEED.




