

RECORD BOUNDARY DESCRIPTION

PART OF BLOCK 3, HERRIMANS' ADDITION, PART OF BLOCK 2, & 3, KINGS ADDITION, PART OF VACATED 30TH STREET, & PART OF LOT 15, BLOCK 10, SOUTH OGDEN SURVEY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF THE INTERSECTION OF PACIFIC AVENUE AND PATTERSON STREET IN OGDEN CITY, UTAH, RUNNING THENCE NORTH 89°02' WEST 20.00 FEET; THENCE NORTH 4°34'10" EAST 412.06 FEET; THENCE NORTH 9°05'20" EAST 241.42 FEET; THENCE SOUTH 89°02' EAST 106.57 FEET; THENCE NORTH 0°58' EAST 273.90 FEET; THENCE SOUTH 89°02' EAST 162.96 FEET; THENCE SOUTH 0°58' WEST 256.15 FEET TO THE NORTH LINE OF KINGS ADDITION; THENCE SOUTH 89°02' EAST 112.50 FEET; THENCE SOUTH 0°58' WEST 185.50 FEET TO THE NORTH LINE OF 30TH STREET; THENCE NORTH 89°02' WEST 37.31 FEET; THENCE SOUTH 0°58' WEST 99.00 FEET TO THE SOUTH LINE OF 30TH STREET; THENCE SOUTH 89°02' EAST 75.00 FEET; THENCE SOUTH 0°58' WEST 108.00 FEET; THENCE NORTH 89°02' WEST 182.70 FEET; THENCE SOUTH 0°58' WEST 156.00 FEET TO THE NORTH LINE OF PATTERSON STREET; THENCE NORTH 89°02' WEST 302.15 FEET TO THE PLACE OF BEGINNING.


THE BASIS OF BEARING IS THE CENTERLINE OF 29TH STREET FROM REEVES AVENUE TO UNION AVENUE WHICH BEARS NORTH 89°01'52" WEST, AN ASSUMED BEARING, ROTATED TO MATCH THE DEED BEARINGS OF THE SUBJECT PROPERTY. SAID BASIS OF BEARING BEARS NORTH 88°41'31" WEST, UTAH NORTH, STATE PLANE, CALCULATED N.A.D.83 BEARING.
