



THE PURPOSE OF THIS SURVEY IS TO PERFORM AN ALTA/NSPS SURVEY ON THE SUBJECT PROPERTY. THE BOUNDARY WAS DETERMINED ON THE NORTH LINE BY FOUND RIGHT OF WAY MONUMENTS AS SHOWN, THE EAST LINE WAS DETERMINED BY ACCEPTING THE EAST LINE SHOWN ON A REDCON RECORD OF SURVEY FILED AS SURVEY # 1645, WHICH WAS RETRACED USING FOUND POINTS SET IN CONJUNCTION WITH SAID SURVEY. THE SOUTH LINE WAS PLACED ALONG THE 40 ACRE LINE AS DETERMINED BY SAID SURVEY. THE DEED DESCRIPTION HAS AN ERRONEOUS BEARING IN THE TIE TO THE SECTION CORNER, IT TIES SOUTH 8'33'07" EAST 601 FEET ALONG THE 40 ACRE LINE. THE WEST LINE WAS PLACED 601 FEET EAST ALONG THE 40 ACRE LINE FROM THE WEST LINE OF SECTION 25 AS ESTABLISHED BY SAID REDCON SURVEY, WHICH PLACES THE LINE NEAR THE EAST SIDE OF AN EXISTING GATE.


