Parcel 15-042-0055

Part of the Northwest Quarter of Section 14, Township 6 North, Range 2 West, Salt Lake Base and Meridian, U.S. Survey: Beginning at a point 4.43 chains South from the Northwest Corner of said Quarter Section, running thence South 721.52 feet, thence East 132 feet, thence South 283 feet to the center of street, thence East 264 feet along the center of said street thence North 17.25 chains to the center of slough; thence following the center of said slough in a Southwesterly direction to the place of beginning

### Parcel 15-043-0002

Part of the Northeast Quarter of Section 15, Township 6 North, Range 2 West, Salt Lake Base and Meridian, U.S. Survey: Beginning at a point on the East line of said Quarter Section, 4.43 chains South 4°05' East from the Northeast Corner of said Quarter Section, Running thence South 4°05' East East 721.52 feet along said Quarter Section line; thence North 89°10'42" West 40 feet, more or less, to the North line of Loud Mytham Farm thence North 88°59'41" West 300.20 feet, thence North 01°13'25" East 361.35 feet thence North 85°55'19" West 302.73 feet along said fence to the center of existing slough, (as per boundary line agreement Entry No. 1989109) thence Northeasterly and Easterly following the center of said slough to the place of beginning.
