


### **VICINITY MAP**

THE BASIS OF BEARING WAS ESTABLISHED BY USING THE FOUND BRASS CAP SECTION CORNERS AT THE NORTHEAST AND SOUTHEAST CORNERS OF SECTION 24, T7N, R2W, SLBM.

#### BOUNDARY DESCRIPTION


