

#### NARRATIVE:

LAYTON SURVEYS WAS CONTRACTED BY DREW TUBBS TO PERFORM A SURVEY OF THE SUBJECT PARCELS FOR THE PURPOSE OF LOCATING THE SAME ON THE GROUND AND COMBINE/CONSOLIDATE TWO CONTIGIOUS WEBER COUNTY PARCELS, PARCEL 08-045-0022 AND PARCEL 08-045-0083, SITUATE IN THE SOUTHEAST QUARTER OF SECTION 7 TOWNSHIP 5 NORTH, RANGE 2 WEST, SL&B.

THE EXISTING DEED FOR DREW TUBBS PARCEL 08-045-0022 WHEN FIRST RECORDED, WAS DONE SO WITHOUT BENIFIT OF SURVEY CAUSING AMBIGUITY WITH TITLE IDENTITY, BASIS OF BEARING AND MORE OR LESS CALLS WHICH CREAT LARGE GAPS BETWEEN ADJOINING PARCELS. THAT CERTIAN DEED DOES SHOW INTENT REGARDING THE EXTENTS OF THE DESCRIBED PARCEL WHEREAS THE PARCEL IS BOUND ON 3 SIDES BY SUBDIVISION PLATS, 1 SIDE BY A RECORDED EASEMENT AND 1 SIDE BY A STREET RIGHT-OF-WAY. THIS SURVEY WAS PERFORMED BY LOCATING THOSE RECORDED ADJOINER LINES ON THE GROUND TO CREATE AN OUTER BOUNDARY FOR AND A TRUE MEETS AND BOUNDS DESCRIPTION (SHOWN) OF THE DREW TUBBS PARCEL. THAT PARCEL WAS THEN TIED TO THE SAME SECTION CORNER AS PREVIOUS

THE BASIS OF BEARING IS FROM MONUMENTS SHOWN HEREON.
