
RUNNING THENCE SOUTH 89°00'00" EAST 382.05 FEET TO THE NORTHWEST CORNER OF PARK SPRINGS P.R.U.D. AMENDED, RECORDED AS ENTRY NO. 2096716 IN THE WEBER COUNTY RECORDER'S OFFICE; THENCE SOUTH 01°00'00" WEST 470.00 FEET TO THE SOUTHWEST CORNER OF SAID PARK SPRINGS P.R.U.D. AMENDED, ALSO BEING A POINT ON THE NORTH LINE OF PLEASANT VIEW 7TH & 9TH WARD SUBDIVISION, RECORDED AS ENTRY NO. 1537386; THENCE ALONG THE BOUNDARY OF SAID PLEASANT VIEW 7TH & 9TH WARD SUBDIVISION THE FOLLOWING THREE (3) COURSES: (1) SOUTH 89°00'00" EAST 362.12 FEET TO THE WEST RIGHT—OF—WAY LINE OF 1100 WEST STREET; (2) SOUTH 01°33'00" WEST 385.00 FEET ALONG SAID WEST RIGHT—OF—WAY LINE; AND (3) NORTH 89°00'00" WEST 740.00 FEET TO THE WEST LINE OF SAID SOUTHWEST QUARTER; THENCE NORTH 00°58'07" EAST 854.98 FEET ALONG SAID WEST LINE TO THE POINT OF BEGINNING. THE BASIS OF BEARING IS THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION WHICH BEARS SOUTH 0°58'07" WEST, UTAH NORTH, STATE PLANE, CALCULATED N.A.D.83 BEARING.
