


#### RECORD BOUNDARY DESCRIPTION

PART OF THE SOUTHWEST QUARTER AND THE NORTHWEST QUARTERS OF SECTION 33, TOWNSHIP 6 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY: BEGINNING AT A POINT EAST 1639.02 FEET AND SOUTH 2164.89 FEET FROM THE NORTHWEST CORNER OF THE NORTHWEST QUARTER; THENCE WEST 326.72 FEET; THENCE NORTH 0°33'10" EAST 154.92 FEET; THENCE WEST 3.3 FEET; THENCE SOUTH 0°16'30" WEST 1950.00 FEET; THENCE EAST 329.97 FEET; THENCE NORTH 0°16'30" EAST 1795.08 FEET TO THE POINT OF BEGINNING. CONTAINING 13.62 ACRES, MORE OR LESS.

#### AS SURVEYED BOUNDARY DESCRIPTION

A PART OF THE WEST HALF OF SECTION 33, TOWNSHIP 6 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY. MORE PARTICULARLY DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT BEING LOCATED NORTH 01°22'09" EAST 1314.53 FEET ALONG THE WEST SECTION LINE OF THE SOUTHWEST QUARTER OR SAID SECTION 33 AND NORTH 90°00'00" EAST 1315.88 FEET FROM THE SOUTHWEST CORNER OF SAID SECTION 33; RUNNING THENCE NORTH 01°23'31" EAST 1980.90 FEET; THENCE SOUTH 89°10'15" EAST 3.30 FEET; THENCE SOUTH 01°22'55" WEST 154.92 FEET; THENCE SOUTH 89°10'15" EAST 327.42 FEET; THENCE SOUTH 01°06'15" WEST 1825.73 FEET; THENCE NORTH 89°12'05" WEST 339.92 FEET TO THE POINT OF BEGINNING. CONTAINING 612,768 SQUARE FEET OR 14.07 ACRES.

# NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JARED KAY. THE BASIS OF BEARING IS THE WEST LINE OF THE SOUTHWEST QUARTER OF SECTION 33, WHICH BEARS NORTH 01°22'09" EAST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BY QUIT CLAIM DEED RECORDED AS ENTRY NUMBER 1538737, AND DEEDS OF ADJOINING PROPERTY OWNERS. RECORD OF SURVEY NUMBERS 451, 5237, AND THE DEDICATED PLATS OF VALLEY GREEN ESTATES NO. 3 AND NO. 4 WERE ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON.
