

### SURVEYOR'S NARRATIVE

This Boundary Survey was done at the request of Angie Craven for the purpose of adjusting the parcels lines.

The Basis of Bearings for this Survey is North 0°03'09" East. Between found Southwest Corner of Section 36 and found West Quarter Corner of Section 36. (As Shown).

Recovered rebars and caps set by Hansen & Associates were found and honored along the East side of the boundary (Weber County Survey No. 5857). The new parcels lines were adjusted according to the Client instructions, and GBE rebars and caps were placed at the locations specified.

#### RECORD DESCRIPTION

#### PARCEL 1: 19-042-0074

A Part of Lot 18, Section 36, Township 7 North, Range 2 West, Salt Lake Base and Meridian, being in the Southwest Quarter of said Section: Beginning at a point 574.00 feet South 56°44' East from the Southwest corner of said Lot 18, and running thence North 13°23'39" East 231.44 feet; thence North 492.56 feet; thence North 89°37'33" East 113.62 feet to the East line of said Lot 18; thence South 828.16 feet along said East line to the North line of Farr West Drive (1898 Plat); thence North 56°44'00" West 200 feet to the POINT OF BEGINNING, TOGETHER WITH the vacated Northerly 20 feet of the street abutting thereon.

#### PARCEL 2: 19-042-0075

A Part of Lot 18, Section 36, Township 7 North, Range 2 West, Salt Lake Base and Meridian, being in the Southwest Quarter of said Section Beginning at a point 574.00 feet South 56°44' East from the Southwest corner of said Lot 18, and running North 56°44'00" West 75.50 feet; thence North 675.53 feet; thence North 89°37'33" East 116.74 feet; thence South 492.56 feet; thence South 13°23'39" West 231.44 feet to the POINT OF BEGINNING.

A Part of Lot 18, Section 36, Township 7 North, Range 2 West, Salt Lake Base and Meridian, being in the Southwest Quarter of said Section Beginning at a point on the South line of said Lot, 498.50 feet South 56°44' East from the Southwest corner of said Lot and running thence North 0°39' West 212 feet; thence South 5°04'35" West (Southwesterly by Record) 199.60 feet to a point 24 feet North 56°44' West of the place of beginning; thence South 56°44' East 24.00 feet to the point of beginning.

Containing 1.802 acres, more or less.

Together with the Vacated Northerly 20 feet of the Street abutting thereon.

### PARCEL 1: 19-042-0074

A Part of Lot 18, Section 36, Township 7 North, Range 2 West within the Southwest Quarter thereof, Salt Lake Base and Meridian, Farr West City Weber County Utah:

Beginning at a point on the North line of Farr West Drive located 1068.56 feet North 0°03'09" East along the Section line and 523.77 feet South 89°56'51" East from the Southwest corner of said Section 36, and running thence North 15°52'48" East 235.92 feet; thence North 80°06'53" West 102.55 feet; thence North 0°06'13" West 483.34 feet to a fence post; thence South 89°51'06" East 234.19 feet along a fence to a Hansen & Associates rebar and cap; thence South 0°17'38" West 855.81 feet to a second Hansen & Associates rebar and cap on the North line of Farr West Drive; thence North 56°15'33" West 231.43 feet along said Farr West Drive to the Point of beginning.

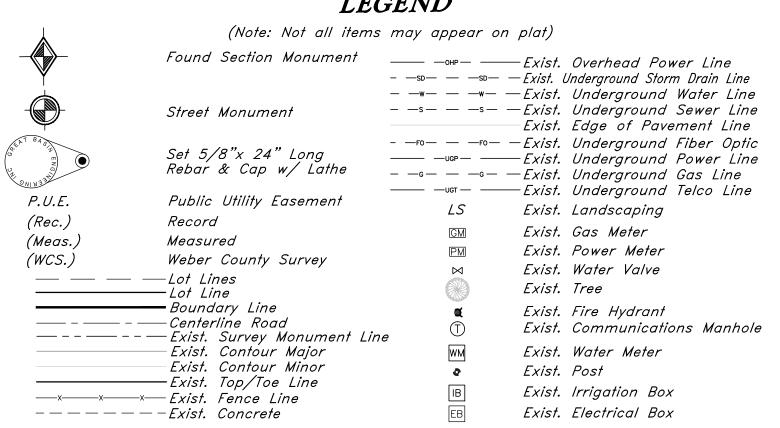
# PARCEL 2: 19-042-0075

Beginning at a point on the North line of Farr West Drive located 1068.56 feet North 0°03'09" East along the Section line and 523.77 feet South 89°56'51" East from the Southwest corner of said Section 36, and running thence North 56°15'33" West 71.91 feet along said Farr West Drive; thence North 6°30'16" East 205.90 feet; thence South 80°06'53" East 102.55 feet; thence South 15°52'48" West 235.92' to the point of beginning.

Contains 18,613 Sq—Ft or 0.43 Acres

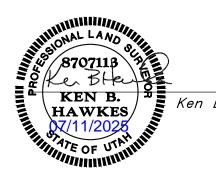
