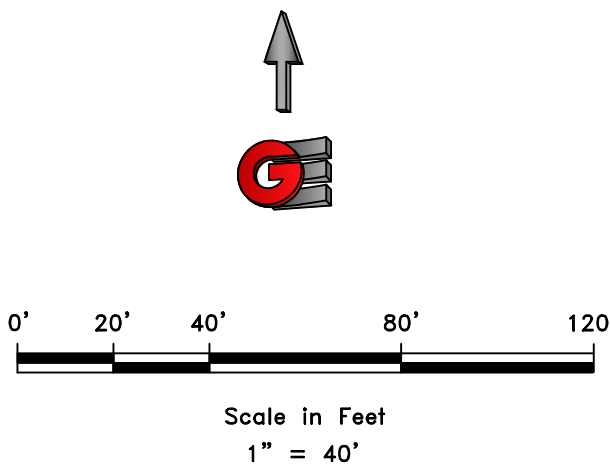

RECORD BOUNDARY DESCRIPTION

PART OF THE SOUTHEAST AND THE NORTHEAST QUARTER OF SECTION 6, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, BEGINNING AT A POINT WHICH IS SOUTH 89D09'30" WEST 650.84 FEET (652.4 FEET) ALONG THE NORTH LINE OF SAID SOUTHEAST QUARTER TO THE WEST RIGHT OF WAY LINE OF THE U.S. HIGHWAY 89, SOUTH 89D09'30" WEST 40.60 FEET ALONG SAID QUARTER SECTION LINE AND SOUTH 251.46 FEET FROM THE EAST QUARTER CORNER OF SAID SECTION 6, (BASIS OF BEARING BEING NORTH ALONG EAST LINE OF SOUTHEAST QUARTER OF SAID SECTION 6 AS MONUMENTED) AND RUNNING THENCE SOUTH 80D26'00" EAST 186.54 FEET TO THE WEST RIGHT OF WAY LINE OF U.S. HIGHWAY 89, THENCE NORTH 26D51'30" WEST 410.84 FEET ALONG SAID WEST LINE, THENCE NORTH 77D49'29" WEST 639.11 FEET TO A FENCE, THENCE SOUTH 0D50'06" WEST 206.40 FEET ALONG SAID FENCE, THENCE SOUTH 62D55'10" EAST, THENCE SOUTH 63D35'45" EAST RECORD 517.24 FEET ALONG FENCE TO A POINT THAT BEARS NORTH 80D26'00" WEST FROM THE POINT OF BEGINNING, THENCE SOUTH 80D26'00" EAST 171.25 FEET, MORE OR LESS, TO THE POINT OF BEGINNING.

NARRATIVE

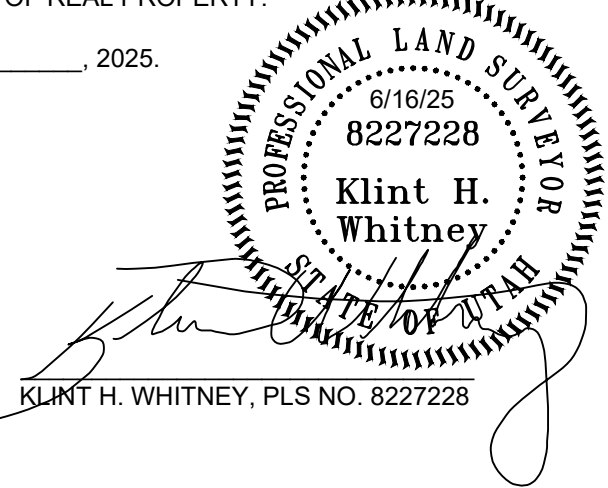
THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY DARREL KOUPAL. THE BASIS OF BEARING IS THE EAST LINE OF THE SOUTHEAST QUARTER OF SECTION 6, TOWNSHIP 6 NORTH, RANGE 1 WEST OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 00°23'20" WEST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BUY WARRANTY DEED RECORDED AS ENTRY NUMBER 3015343, AND DEEDS OF ADJOINING PROPERTY OWNERS. RECORD OF SURVEY NUMBERS 255 4274, 7539, 8019 WERE ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON.

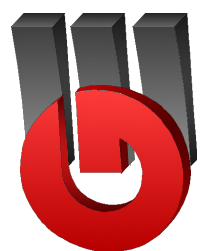
