


## RECORD BOUNDARY DESCRIPTION

PART OF THE WEST 1/2 OF THE SOUTHEAST QUARTER OF SECTION 32,AND PART OF AN UN NUMBERED LOT IN PLAIN CITY SURVEY, TOWNSHIP7 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S.SURVEY: BEGINNING AT A POINT WHICH IS 4 RODS SOUTH AND 185.45FEET WEST FROM THE SOUTHWEST CORNER OF BLOCK 3, PLAT A, PLAIN CITY SURVEY, AND RUNNING THENCE SOUTH 114.5 FEET, THENCE EAST9.0 FEET, THENCE SOUTH 45D WEST 134.35 FEET, THENCE WEST 5FEET, THENCE NORTH 209.5 FEET, THENCE EAST 100 FEET TO THE POINT OF BEGINNING. ALSO: PART OF THE WEST 1/2 OF THE SOUTHEAST QUARTER OF SECTION 32 AND PART OF AN UN-NUMBERED LOT IN PLAIN CITY SURVEY, TOWNSHIP 7 NORTH, RANGE 2 WEST, SALT LAKE BASE &MERIDIAN, U.S. SURVEY: BEGINNING AT A POINT WHICH IS 280.5FEET SOUTH AND 176.45 FEET WEST FROM THE SOUTHWEST CORNER OF BLOCK 3, PLAT A, PLAIN CITY SURVEY, AND RUNNING THENCE WEST109.00 FEET, THENCE NORTH 5 FEET, THENCE EAST 5 FEET, THENCE NORTH 45D EAST 134.35 FEET, THENCE SOUTH 100.00 FEET, MORE OR LESS, TO THE POINT OF BEGINNING.

## AS SURVEYED BOUNDARY DESCRIPTION

A PART OF THE SOUTHEAST QUARTER OF SECTION 32, TOWNSHIP 7 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN. BEGINNING AT A POINT ON THE SOUTH RIGHT-OF-WAY LINE OF 2200 WEST STREET BEGIN LOCATED SOUTH 00°41'59" WEST 3342.06 FEET ALONG THE EAST LINE OF SAID SECTION 32 AND NORTH 90°00'00" WEST 1435.21 FEET FROM THE NORTHEAST CORNER OF SAID SECTION 32; RUNNING THENCE SOUTH 00°56'24" WEST 113.94 FEET; THENCE SOUTH 88°40'55" EAST 9.00 FEET; THENCE SOUTH 00°56'24" WEST 100.56 FEET; THENCE NORTH 88°40'59" WEST 113.95 FEET; THENCE NORTH 00°56'24" EAST 214.50 FEET TO SAID SOUTH RIGHT-OF-WAY LINE; THENCE ALONG SAID SOUTH RIGHT-OF-WAY LINE SOUTH 88°40'55" EAST 104.95 FEET TO THE POINT OF BEGINNING.



## NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY DARLENE FILBAN. THE BASIS OF BEARING IS THE EAST LINE OF SECTION 32, TOWNSHIP 7 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 00°41'59" WEST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BUY QUIT CLAIM DEED RECORDED AS ENTRY NUMBER 2520213, AND DEEDS OF ADJOINING PROPERTY OWNERS. THE DEDICATED PLATS OF PLAIN CITY PLAT WAS ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON. OCCUPATION WAS MEASURED OVER MULTIPLE BLOCKS TO DETERMINE ROADWAY CENTERLINES. SAID CENTERLINES WERE THEN OFFSET BY DEEDED DISTANCES TO ELIMINATE THE ERRORS IN THE MEETS AND BOUNDS DESCRIPTIONS CONTAINING IN THE DEEDS.
