This record of survey and lot line adjustment was requested by Kevin Smith for the purpose of Adjusting Lots 6 and 7 of the Gleave Subdivisoin 1st Amendment.

By deed, 1725 East Street exists as a 25 foot right—of—way. Centerline was established by dividing said right—of—way evenly.

A line bearing South 89°21'38" East between the Brass Cap for the North Quarter Corner of Section 27 and the Brass Cap Monument for the Northeast Corner of Section 27, was used as the Basis of Bearings for the survey. Rebar and Caps were set at the new corners as shown here on.


