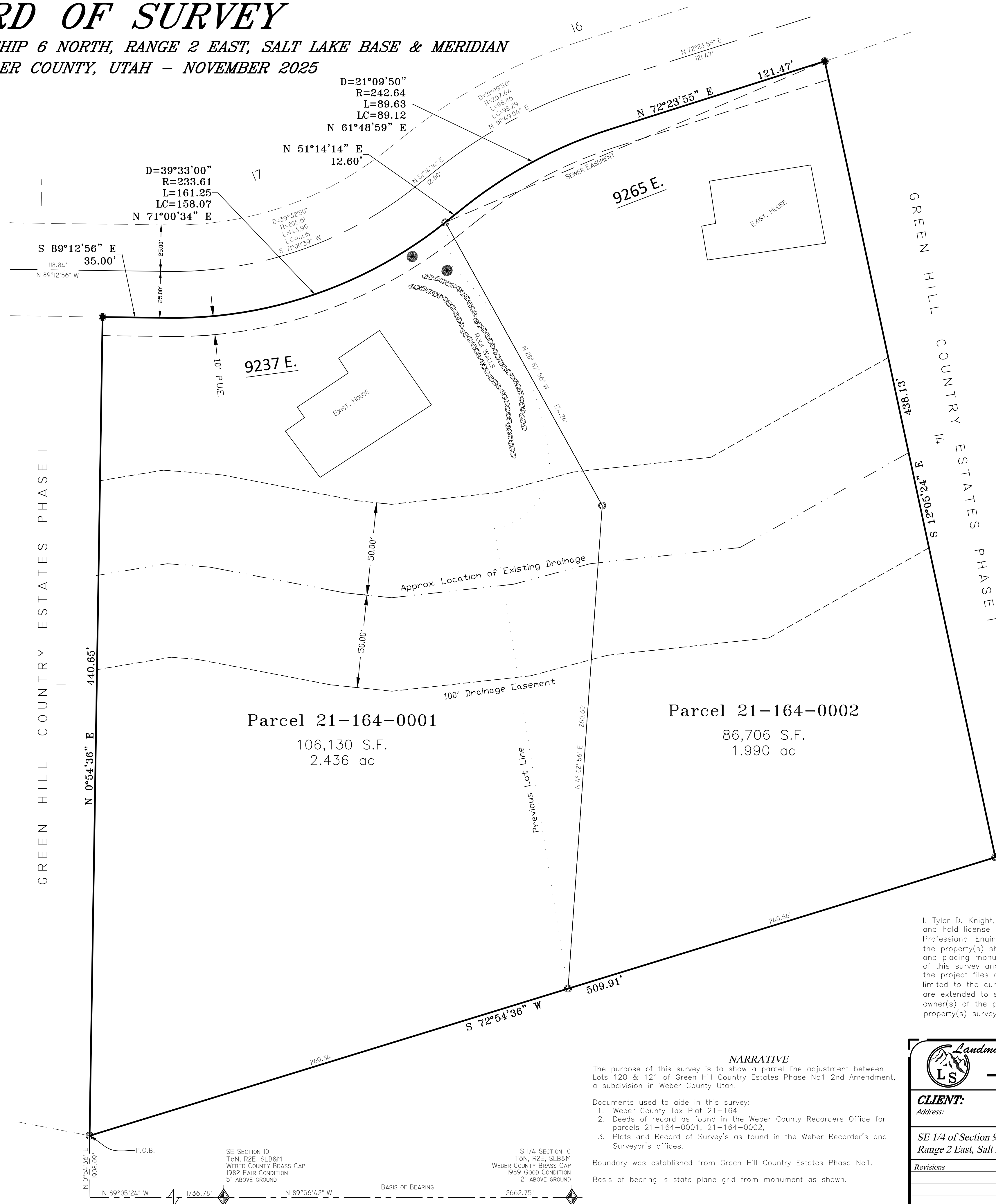


PART OF THE SE 1/4 OF SECTION 9, TOWNSHIP 6 NORTH, RANGE 2 EAST, SALT LAKE BASE & MERIDIAN

### BOUNDARY DESCRIPTION

Parcel 21-164-0001

A tract of land located in the Southeast Quarter of Section 9, Township 6 North, Range 2 East, Salt Lake Base and Meridian, being a part of the Green Hills Country Estates Phase 1 development, described as follows:

Beginning at the Southeast corner of Lot 11 of said subdivision, which point is 1736.78 feet North 89°05'24" West and 1808.05 feet North of 0°54'36" along the Southeast corner of said Section 9, and running thence North 0°54'36" East along the East line of said Lot 11 44.605 feet to the South right-of-way of Kelley Drive, a private road; thence along said right-of-way the following two (2) courses: (1) South 89°12'56" East 35.00 feet to a point of curvature, and (2) along the arc of a 233.61 foot radius curve to the left a distance of 161.25 feet (Central Angle = 39°33'00") and Long Chord bears North 71°00'34" East 158.07 feet; thence South 28°57'56" East 174.724 feet; thence South 04°02'56" West 260.60 feet to the Southerly line of said subdivision; thence South 72°54'36" West 269.34 feet to the point of beginning.

Parcel 21-164-0002

A tract of land located in the Southeast Quarter of Section 9, Township 6 North, Range 2 East, Salt Lake Base and Meridian, being a part of the Green Hills Country Estates Phase 1 development, described as follows:

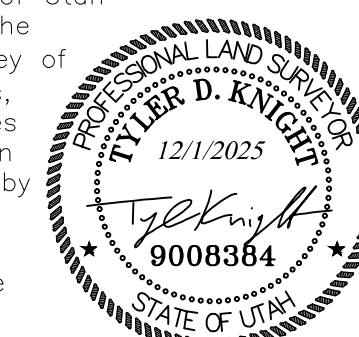
Beginning at the Southwest corner of Lot 14 of said subdivision, which point is 1736.78 feet North 89°05'24" West, 1908.09 feet North 07°54'36" East, and 509.91 feet North 72°54'36" East from the Southeast corner of said Section 9; and running thence North 72°54'36" West 240.56 feet along the South line of said subdivision thence North 04°02'56" East 260.60 feet; thence North 28°57'56" West 174.24 feet to the South right-of-way of Kelley Drive, a private road; thence along said right-of-way the following three (3) courses: (1) North 51°14'34" East 12.60 feet to a point of curvature; (2) along the arc of a 242.64 foot radius curve to the right at a central angle of 102°05'24" East 12.60 feet to a point of tangency; and (3) Chord bears North 51°16'50" East 24.26 feet; and (3) North 72°23'55" East 121.47 feet to the West line of said Lot 14; thence along said West line South 12°05'24" East 438.13 feet to the point of beginning.
