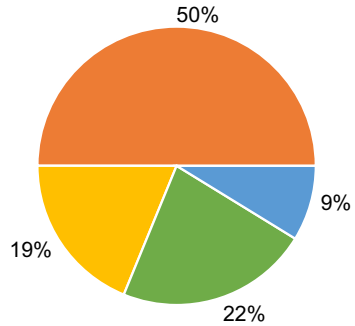

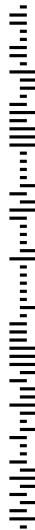

THIS STATEMENT IS A NOTICE OF YOUR PROPERTY VALUATION

This Notice is not a bill. The Weber County Treasurer will send your Tax Bill in October. If you have questions about tax payments, pre-paid tax amounts, and delinquent taxes, call the Treasurer's Office at the number listed below.

Why am I receiving this Notice?

- To inform you of the Assessor's classification and value for this property and your opportunity to appeal.
- To show you a comparison of last year's and this year's value, tax rates and tax amounts.
- To notify you of an entity's intent to raise taxes above the amount allowed by law (Utah Code 59-2-919).
- To let you know how your tax dollars are allocated to the various government organizations in your area.

This Notice does NOT include:

- Pre-payments made to your 2023 property taxes.
- Tax Relief adjustments (See the list of Tax Relief programs below).
- Any delinquent property taxes you may owe.

What do the different columns on the other side of the page mean?

Property Type – The type and classification of your property. This may affect taxable value.

Last Year's Market Value – The value of your property on January 1st of last year.

Last Year's Taxable Value – The value of your property that you were taxed on for last year.

This Year's Market Value – The value of your property on January 1st of this year.

This Year's Taxable Value – The value of your property that you will be taxed on for this year.

Taxing Entities – The government organizations that charge you a tax for the area you live in.

Taxes Last Year – The tax rate and tax amount entities set for last year.

No Budget Increase – The tax rate and tax amount allowed for this year without advertising for a tax increase.

Proposed Budget Amount – The tax rate and tax amount the entities are requesting for this year.

NOTE: To compute the dollar amount of taxes charged, multiply the tax rate by the taxable value.

Changes and Public Hearings – The dollar amount of proposed increase, percent of increase, and date, time and place of required meetings for entities raising their tax above the allowed amount.

Do I qualify for Tax Relief?

You may be eligible for one or more Tax Relief programs. For additional information about Tax Relief programs, visit the Weber County website at www.WeberCountyUtah.gov/Clerk_Auditor/tax_relief.php or call **(801) 399-8489**.

- **Circuit Breaker Program** - If you are age 66 or older, or a widow/widower of any age, and your 2022 total household income was less than \$38,369 you may qualify for the Circuit Breaker Program.
- **Abatement Program** - If you are experiencing extreme financial hardship and/or you have a medical disability, you may qualify for the Abatement Program.
- **Veteran With A Disability Exemption** - If you are a veteran with a service-related disability of 10% or more, or are the unmarried surviving spouse or minor orphan of a deceased veteran with a service-related disability of 10% or more, you may qualify for tax relief on real and/or personal property.
- **Deployed Military Personnel** - If you served in a qualified active duty status for at least 200 days in a continuous 365-day period outside the state in the prior year, you may be eligible for tax relief.
- **Blind Exemption** - If you are blind, or are the unmarried surviving spouse or minor orphan of a deceased blind person, you may qualify for tax relief on real and/or personal property.
- **Senior Tax Deferral** - If you are age 75 or older, your total household income was less than \$76,738, and your home meets certain ownership and valuation requirements, you may qualify for a property tax deferral. Unlike other programs, deferred property taxes and interest will be due when the property is no longer your primary residence.

YOU MUST FILE FOR TAX RELIEF BY SEPTEMBER 1, 2023 APPEAL INFORMATION

If you disagree with the 2023 market value or classification of your property, you may file an appeal with the Weber County Board of Equalization. Appeal applications are available on our website, in our office, or you may contact us at **(801) 399-8112**.
